



RECORDING AND PUBLICATION CONSENT FORM

We are delighted that you will be presenting in the upcoming 34th European Congress of Psychiatry – EPA 2026 (the “Congress”) organised by the European Psychiatric Association (hereinafter the “EPA”), located 15 Avenue de la Liberté, 67000 Strasbourg (France). A number of sessions at the Congress may be recorded live at the Congress and will subsequently be made available for access and/or distribution during and/or after the Congress. It is intended that the recordings will contain video, audio, slides, Q&A, text and photographs, or any of the foregoing.

As a speaker and/or moderator at EPA 2026, we are requesting your permission to record all your presentations and contributions at the Congress (together, the “Presentations”).

We consider it particularly important to clarify the following points:

- Speakers are responsible for submitting presentation and all other materials by the deadlines outlined by EPA.

- Presentations will be broadcasted and will also be recorded as a video featuring the slides used during the presentation and accompanied by synchronized spoken/video comments and explanations.
- To ensure that the live and the recorded version of the presentation are identical, **the presenter will not have the option to indicate slides not to be included as part of the recording.**

By signing this consent form, you represent, acknowledge, agree and consent that:

1. Each of the Congress organisers, including the EPA and MCI Suisse SA or its affiliates (together, the “Organisers”) is authorized to record all or any part of the Presentations (including your image and your voice), in any format chosen by any of them in any manner whatsoever, in their absolute discretion.
2. The Presentations (including your image and voice) may be live broadcasted or subsequently broadcasted via the internet by the Organisers.
3. EPA may use, reproduce, publish, translate, edit, distribute, broadcast and otherwise display the Presentations or any part thereof, or grant third parties rights to do so, all on a royalty-free, perpetual, irrevocable nonexclusive basis, provided that it is used solely for educational purposes and in a manner approved by the EPA.
4. To immediately notify the Organisers upon becoming aware of any content-related issues (slide withdrawals, copy-right clearance issues, mistakes in the accuracy of information, accidental disclosure of protected information, etc.).
5. You have full right, interest and authority: i) in respect of the Presentations and their content, and ii) to grant to the Organisers all of the rights so granted hereunder, and that neither the Presentations nor their content breaches the copyright of any third party.
6. For Presentations made in the frame of acknowledged sponsored activities, the acknowledged funding organisation shall be granted the same rights hereby granted to the Organisers and to the EPA limited to the sole Presentations of that activity.

This Consent Form shall be governed by and construed in accordance with the laws of France. The Courts of Strasbourg (civil chamber) shall have exclusive jurisdiction to settle any dispute which may arise out of or in connection with this Consent Form and accordingly, any suit, action or proceedings arising out of or in connection with this Consent Form shall be brought in such courts.
